EXECUTIVE SUMMARY

This item creates a RAD Subcommittee/Working Group to explore the licensing of legal technicians or creating a limited license to practice law by which those not fully licensed as attorneys are enabled to provide limited, discrete legal services to consumers in defined legal subject matter areas. This has been a subject of discussion at the State Bar for 20 years. In light of action taken creating a limited license to practice law for legal technicians in Washington State and the actions of the Law Society of Upper Canada licensing and regulating paralegals, this was identified by the Board at its January planning meeting for exploration. As this is a regulatory item, it is appropriate for RAD to explore the issue. To do so, RAD is creating a subcommittee/working group to be appointed by the RAD Chair, to explore the issues and make recommendations to RAD for action.
